Università Politecnica delle Marche, Italian Republic (hereinafter referred to as "UnivPM"), and Navrachana University, India, (hereinafter referred to as "NUV"), in recognition of their common interests in developing bilateral relations are convinced that cooperation between Institutes contributes to cultural enrichment, scientific progress, and the consolidation of friendship between the two countries, agree to establish the following Memorandum of Understanding.

**I**

This Memorandum of Understanding will generally promote activities in the following principal areas:

- Exchange of students
- Exchange of staff
- Collaborative research, instructional and cultural programs
- Exchange of research information

**II**

Specific mechanisms for the implementation of cooperative and collaborative activities named above shall be established and described in corresponding Annexes to this Memorandum of Understanding.

### III

All activities developed under the auspices of this Memorandum of Understanding will respect and conform to the corresponding norms, traditions and regulations of each institution, its country and region.

### IV

Medical insurance for mobility students and researchers will be provided according to the current norms of the host country. In case there are no international agreements for medical insurance, the visiting person can provide for a medical insurance policy by himself.

### V

If any dispute arises between the parties, they shall respond in good faith and endeavor to reach an amicable settlement. Disputes that cannot be amicably resolved shall be subject to legal measures including arbitration and lawsuit.

### VI

The institutions agree to negotiate diligently and in good faith with respect to any intellectual property rights developed in the course of collaborative activities carried out under the terms of the present Memorandum of Understanding. If proven necessary, intellectual property agreements shall be subsequently and separately drawn in accordance with the policies of each institution and their respective national laws.

### VII

The Parties/institutions undertake to process all personal data solely for the purpose connected to the execution of this Memorandum of Understanding and in accordance with European Regulation (GDPR 2016/676).

### VIII

In the case of joint cooperation programs, each institution will have to decide the relative source of funding. If necessary, specific agreements will be developed for the individual activities. These

specific agreements will be considered as annexes to the present Memorandum of Understanding.

## IX

This Memorandum of Understanding is established for a period of five years, effective from the date of signing.

In order to enhance the efficacy of their cooperative activities, **UnivPM** and **NUV** agree that it shall be possible to introduce changes and additions to this Memorandum of Understanding by means of mutually agreed upon additional written clauses.

At the end of each five-year period, this Memorandum of Understanding may be renewed by mutual written consent after assessment of the partnership.

The contact reference for **NUV** is Prof. A. V. Ramachandran, and the contact reference for **UnivPM** is Prof. Oliana Carnevali.





## Memorandum of Understanding

### Preamble

This agreement is made this 21<sup>st</sup> June day of 2022 between Bob Jones University (BJU) and Navrachana University (NUV).

In the spirit of cooperation and mutual interests, BJU and NUV enter into this Memorandum of Understanding (MOU) to promote joint educational and cultural collaboration. The MOU shall be in effect for five years and may be terminated within 60 days in writing by either party.

This MOU is not intended by the parties to be legally binding. Any binding obligations will be the subject of later, definitive agreements negotiated between the parties. Nothing in this MOU is intended to create a legal partnership or joint venture or is intended to create any new academic programs.

### Article 1: Scope

Either institution may propose specific areas of collaboration or projects related to:

1. Joint research
2. Professional development for faculty, staff, and/or students
3. Student internships
4. Cultural activities

Any specific activity developed under this MOU shall be detailed in a subsequent agreement, signed by each party's authorized representative, which will describe the scope of the proposed activity, intended outcomes, funding, budget, data sharing, intellectual property rights, and responsible departments or individuals. All activities shall be subject to the availability of funds and the approval of each party's authorized representatives.

### Article 2: Use of Branding Materials

None of the parties shall use the name, logo, likeness, trademarks, image, or other intellectual property of either of the other parties for any advertising, marketing, endorsement, or any other purposes without the specific prior written consent of an authorized representative of the other party as to each such use.





### **Article 3: Assignment**

No party may assign this MOU or any rights or obligations under this MOU to any person or entity without the prior written consent of the other parties. Any assignment in violation of this provision is null and void.

### **Article 4: Governing Law**

The parties specifically agree to comply with all applicable laws, rules, and regulations at the local, state or province, and national levels for activities identified in this MOU.

### **Article 5: Grants**

The parties agree to pursue grants to fund specific joint research projects and other activities associated with this MOU. All projects requiring funding through grants must be authorized by a separate agreement as detailed in Article 1.

### **Article 6: Funding**

Each party will be responsible to supply funding as required to support their own personnel and activities related to projects authorized by this MOU. Formal, project-specific funding may be negotiated between the parties as the need arises. Funds from grants may be used for costs and expenses to support individuals connected to this MOU.

### **Article 7: Insurance**

Each party will be responsible for ensuring adequate medical insurance coverage, applicable in the country of the host, for the duration of their visits. Insurance certificates may be required to verify coverage.

### **Article 8: Research Ethics**

Parties agree that adequate safeguards shall be taken whenever using human or animal subjects in research, consistent with applicable laws and policies regarding the use of human and animal subjects, including training of such trainees, faculty, or staff, an institutional review committee, research ethics board, or animal care and use committee composed of members with varying backgrounds who will perform complete and adequate review of projects involving the use of such subjects. Informed consent shall be obtained in accordance with national laws and regulations, international research standards, and accepted guidelines on good research practices and ethics. Each participant shall, to the extent necessary for the legal conduct of activities under this MOU, comply with the applicable laws and regulations at the site of the collaboration or project.

### **Article 9: Confidentiality**

Activities under this MOU may require the parties to disclose confidential information. Unless otherwise expressly permitted in this agreement, any and all information, correspondence, financial statements, records, data, or information that is competitively sensitive and not generally known to the public, including formulations, analysis, inventions, improvements and activities of the disclosing party, disclosed by one party to the other party of this MOU, and other documents transmitted or communicated by either party to the other party that is marked as confidential or proprietary for the





purposes of this agreement ("Confidential Information") shall be received and treated in confidence, and shall not be used by the receiving party or disclosed by the receiving party without the prior written consent of the disclosing party, which consent shall not be unreasonably withheld or delayed.

Data connected to a specific project may be shared between parties by whatever secure means are available to both parties.

#### Article 10: Indemnification

BJU agrees to defend, indemnify and hold NUV, its officers, employees and agents harmless from and against any and all liability, loss, expense, attorneys' fees, or claims for injury or damages arising out of the activities under this MOU, but only in proportion to and to the extent such liability, loss, expense, attorneys' fees, or claims for injury or damages are caused by or result from the negligent or intentional acts or omissions of BJU.

NUV agrees to defend, indemnify and hold BJU, its officers, employees and agents harmless from and against any and all liability, loss, expense, attorneys' fees, or claims for injury or damages arising out of the activities under this MOU, but only in proportion to and to the extent such liability, loss, expense, attorneys' fees, or claims for injury or damages are caused by or result from the negligent or intentional acts or omissions of NUV.

Both parties agree to make efforts in good faith to resolve all disputes amicably and expeditiously between themselves.

#### Article 11: Institutional Representatives

Both parties agree to designate one individual to administrate this MOU and to function as the primary conduit for communication between the parties. All formal notices must be in writing and are effective upon receipt. Notices may be transmitted via email or through other means such as the postal system or delivery services.

**MEMORANDUM OF AGREEMENT

This Memorandum of Agreement (the "MoA") establishes a formal mutually rewarding collaborative relationship and academic partnership between Navrachana University (NU), located at Vasna Bhayli Road, Vadodara -391 410 Gujarat, India, and The State University of New York by and on behalf of The State University of New York at Binghamton (Binghamton University), located at 4400 Vestal Parkway East, Binghamton, NY, U.S.A. The collaboration aims to foster advancement in teaching, research, academic collaboration and cultural understanding and to create avenues for enhancing learner experience at both entities, as well as strengthen both entities by finding ways of combining their complementary resources and strengths.

**ARTICLE 1  
SCOPE OF COOPERATION**

For Binghamton University, the Thomas J. Watson College of Engineering and Applied Science shall be the college that leads the collaboration between the two universities.

Both parties agree that the intention of this partnership is to create a specific foundation to encourage exchange and sharing of academic, scientific, and cultural experiences amongst their professors, students, and administrative personnel. As part of this collaboration, NU and Binghamton University will broadly explore the following avenues for cooperation:

- i. Short courses, seminars, workshops, and courses provided by Binghamton University to NU.
- ii. Collaborations on industry/university partnerships.
- iii. Faculty, student, staff, and/or administrator visits (from NU to Binghamton University, and vice versa).
- iv. Support of conferences and workshops; the mode of support will be determined depending on topic, timing, and other considerations.
- v. Knowledge-sharing and collaborations pertaining to the incubation of start-up companies.
- vi. Faculty development programs, including those that focus on (i) pedagogy and the (ii) assessment and evaluation of educational programs.

The specific terms of collaboration for each initiative implemented under this MoA shall be mutually discussed and agreed upon in writing within separate agreements for each specific case by both partners prior to the initiation of the particular activity or program. Each party will designate a Liaison Officer to develop specific activities or initiatives under this MoA for approval of both parties.

**ARTICLE 2  
DURATION, TERMINATION, AND AMENDMENT**

The terms of this MoA shall commence on the Effective Date, defined here as the date of last signature, and continue for a period of five (5) years, and may be subject to extensions by mutual consent. Either party may terminate this MoA by giving sixty (60) days advance notice in writing.

The provisions of this MoA may be amended at any time with the mutual consent of the parties in writing. If any programs are in effect at the time this MoA expires or is terminated, the parties will work together in good faith pursuant to the terms of the program agreement to ensure that the participating students, faculty and staff are able to complete their academic program if practicable.

**ARTICLE 3  
USE OF NAME**

If the parties enter into a collaborative agreement with respect to any of the areas of cooperation addressed in this Memorandum of Agreement, either institution shall be allowed to promote that the other institution is its partner with respect to that particular program. This permission is limited to the use of the names and/or logos in advertisements and published materials that are primary to the originating organization in a manner that complies with the then-current logo use policy and is pre-approved in writing by the other institution. Each institution reserves the right to audit any and all materials at any time. Upon a written request for examples of materials, either institution must deliver examples of all requested materials within 30 days. If the usage of the logo/name is unacceptable to the requesting party, upon receipt of a written request from the partner, the organization must immediately stop publishing that usage of the logo and/or name, and make best efforts to immediately take any occurrence of the requested usage of such logo and/or name out of circulation.

This MoA is prepared in two identical copies; each partner will hold one original copy duly signed by authorized representatives of each entity.


Both institutions intend to seek opportunities to collaborate across a range of activities, including:



**MEMORANDUM OF UNDERSTANDING**

**I. PREAMBLE**

In accordance with a mutual objective to promote further cooperation between India and the United States of America, Navrachana University, India and North Dakota State University (NDSU) hereby jointly enter into a bilateral linkage, focusing on the development of their institutions' programs. They will jointly develop and implement activities to improve their capacities to serve their respective clientele in India and in the United States of America. This linkage is developed based upon the institutions' commonality of interests and their belief that a linkage between them would strengthen their joint and individual capacities.

**II. OBJECTIVES**

The objectives of this linkage are to develop long-term cooperative activities. The activities may include, but are not limited to, the following:

- 1) Share knowledge.
- 2) Develop collaborative research and education programs.
- 3) Develop exchange and professional development programs for students, staff and faculty.
- 4) Conduct seminars and workshops.
- 5) Cultural exchange through mutual assistance in the areas of education and research.
- 6) Share new technologies and new methods of management through extension and other programs.
- 7) Seek funding opportunities for joint activities which provide mutual benefit to each institution's teaching, research and outreach programs.

**III. PROGRAM MANAGEMENT**

North Dakota State University and Navrachana University jointly agree to develop and establish provisions for program implementation that will serve the mutual interest of both institutions.

It is understood that the details of joint activities, conditions for utilization of results achieved, and arrangements for specific visits, exchanges and other forms of cooperation will be negotiated for each specific type of activity.

It is also understood that financial arrangements will be negotiated in each specific type of activity and will depend upon the availability of funds. Each party agrees to seek financial resources for supporting the exchange and collaboration. The contact and exchanges between the two parties shall be on the basis of friendship, equality, and mutual assistance.

The linkage program at North Dakota State University will be supervised by a designated department. The program at Navrachana University will be under the jurisdiction of Dr. Nilay Yajnik, Provost.



#### IV. TERMS OF UNDERSTANDING

This understanding is effective on the date of the last signature hereto and will remain in effect for an initial period of ten years and may be extended for a period as mutually agreed by both parties. The agreement can be terminated by either institution by giving one year's notice to the other party.

The activities under this understanding will be reviewed on an annual basis as mutually agreed and plans for future activities will be developed each year immediately following the review.





- B) Both the institutions shall evolve a mutually acceptable schedule to develop programs, hold seminars and/or workshop and exchange visits.

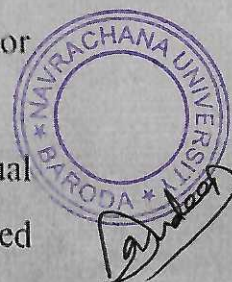

- E) Collaborate in the starting of a certification course on regulatory affairs for biopharmaceuticals under the Centre for Environment and Health and mutual support for the conduction and planning of the program..
- F) Explore the possibility of submitting a grant application to DBT for setting up a Centre for Bioinformatics at NUV under the guidance and input of Prof Alex Feltus from Clemson University. Dr. Rebecca Garcia would help us connect to the expert in US and we would take things forward from there.
- G) Co-Diagnostics, would welcome students of NUV for training and dissertation work. Co-Diagnostics would also offer summer training and the detailed schedule and time line shall be agreed upon mutually.
- H) To meet periodically to review and evaluate past activities and to work out new ideas for future cooperative agreements
- I) The parties to this memorandum may, by mutual consent, add modify, amend, delete, review or revise any tem(s) and condition(s) of this agreement.
- J) This Memorandum / Agreement is not a contract. This Memorandum / Agreement serves only as a statement of the general intention of the Parties and is not intended to be legally binding nor to be construed as an agreement on any matters mentioned. No oral agreement or conduct of the Parties (including partial performance) in respect of matters stated in this Memorandum / Agreement shall be deemed to impose any obligation or liability on either Party.
- K) Should any faculty collaboration result in any potential for intellectual property, the parties will immediately meet through designated

representatives and seek an equitable and fair understanding as to ownership and other property interests that may arise. Any such discussions will at all times strive to preserve a harmonious and continuing relationship between the parties.

- L) The MOU shall remain in force for a period of 5 years from the date of its signature and seal, and may be terminated by either side by giving a six months notice to that effect in writing. However, notwithstanding the notice of the intent to terminate the memorandum, all rights, obligations and corresponding duties and subsisting therein shall be respected and mandated till the finalization and accomplishment.
- M) Notwithstanding the above, the period of this cooperation shall be extended as long as desired by the Parties.




